The Furnishing, Operation and Maintenance of the **Log huts, Cafeteria , Cultural Activity Centre, Traditional Shops, Gazebo etc at Umiam (Lake View)** will be through lease of the constructed facilities by the bidder for Tourism activities. The Eligibility and Financial criteria along with process of selection of the entrepreneur/consortium are given in the RFP document.

The last date for submission of the bids completed in all respects is 6th May 2019 at **11.00 am** and proposals will be opened at **3.00 pm** on the same day.
